Payment Instructions

1. Verify the legal description of the property. If this is for property you no longer own, please disregard this notice.
2. Verify your mailing address above. If your mailing address has changed, go to www.SC-PA.com and click "Change Mailing Address".
3. Choose one of the following payment methods. **The June amount due is valid only if paid or postmarked by June 30, 2026.**

www.SarasotaTaxCollector.gov: eCheck - no fee or Credit/Debit - additional fees; fees charged by the payment processor.

eBanking/Bill Pay: Create a payee for "Tax Collector Mike Moran" as your bank instructs. Please include your account number. If you have multiple bills, complete a separate payment for each account. **Remember, for your payment to reach our account by the payment due date, you must initiate your payment with sufficient lead time.**

By Mail: Detach and return the bottom portion of this notice with your check. Check must be drawn on a U.S. bank, in U.S. funds, and made payable to "Tax Collector Mike Moran". You may send one check for multiple bills.

In Person: Appointment strongly recommended (required at North Port City Hall) and can be scheduled at www.SarasotaTaxCollector.gov. Please bring your entire bill for a paid receipt.

24-Hr. Drop Box: Place your payment in a drop box by 5:00 pm on the payment due date. Checks only; do not place cash in the drop box.
